

FSC & EUDR: INDEPENDENT ASSESSMENT CONFIRMS STRONG ALIGNMENT



ASI (Assurance Services International) independent benchmarking confirms: **FSC** (Forest Stewardship Council) provides the tools companies need to meet **EUDR** (EU Deforestation-Free regulation) requirements.

SCHEMES CAN SUPPORT EUDR COMPLIANCE - IF THEY ARE ALIGNED



The EUDR requires companies placing forest products such as wood and rubber on the EU market to ensure they are legal and deforestation-free.



The European Commission's Guidance advises that if companies use certification schemes to support EUDR compliance, they must first confirm the scheme aligns with EUDR requirements.

FSC SHOWS STRONG ALIGNMENT WITH EUDR

ASI benchmarked FSC against EUDR guidance document and found:



FSC core certification already meets most EUDR criteria, including:

- ✓ Third-party verification
- ✓ Strong transparency (public certificate database)
- ✓ No mixing of unknown-origin materials
- ✓ Mechanisms for reporting and addressing issues

Minor gaps remain, mainly temporary, linked to ongoing normative framework revisions. Once the transition is completed, FSC's core certification will mostly align with EUDR.



FSC Regulatory Module is already fully aligned with EUDR

- ✓ Regulatory Module is a voluntary add-on for FSC CoC, FSC Forest Management, FSC Controlled FM and FSC Project Certification
- ✓ Collects geolocation & production date
- ✓ Ensures deforestation-free supply chains
- ✓ Risk assessment & mitigation
- ✓ EUDR-aligned definitions (deforestation, legality)
